



Notes for 2021 Election

- Regional allocation of the 8 open seats, 1 seat must be held for each of the following regions: BC/YT, SK, QC & Atlantic (As they are currently vacant). The other 4 can be allocated to any province (to a maximum of 3 seats per province).
- Seats are open to all members in good standing.
- Restrictions: Directors must not have direct interest in the commercial selling or certifying of fair trade products (in accordance with the bylaws).

Election Process

- A vote will then be carried out
- Votes will be tabulated, and ranked in order of most votes
- The top candidates from BC/YT, SK, QC & Atlantic will be elected, and remaining four (4) seats will be elected in order of most votes
