3 Budget

- a) Current state
 - a. Have not got a projected budget out to everyone,
 - b. Good shape, McConnell money is providing a good base.
 - c. This will be coming to an end soon-ish.
 - d. Need to get a grasp on the situation soon.
 - e. McConnell retreat is taking place in April, Sean will be attending. Hope to re-apply for the grant.
- b) Looking forward, 2017 -18
 - I. Contracts (Service)
 - i. Fairtrade Canada contract, is being worked on.
 - II. Foundations
 - i. Have been in contact with the Mclean foundation.
 - ii. Last month Sean met with the Gate's Foundation. They provided EWB with a million dollars
 - iii. Lush Grant, has been worked on.
 - iv. Tried to hire someone, however, it did not work out. Will be looking for someone else to



fill this role. If you know of interested people, please pass their name along.

v. Loic would be interested in sitting down and working through some proposals. Could partner with the Quebec organization to create a very strong proposal.

III. General discussion

- i. As a national organization, we are unable to apply for funds provincially.
- ii. SFU as a partner needs to be solidified. We could communicate this relationship with the rest of the network. Maybe there is room for growth in this area into other campuses. Oliver from McGill expressed interest.
- iii. We need to have grant proposals completed in the next four weeks.
- iv. Have a current budget, financial plan ready for the April 24th meeting.
- v. Know exactly where we are financially by the in-person meeting in June.

4 Strategic Plan

- Lots of little tweaks and edits will be made to the strategy from the conference.
- How do we get more producer input in our work, is this inviting someone onto the Advisory Council? We
 don't need input on all the work we do, but some. Origin Trips are a great area to get input from
 producers.
- How do we include out new position on certification into our work? Need to work the certifications into Action Plans. A conversation to approach later in the year. How do we have these conversations? And who exactly will be in these conversations?
- Some of these topics should be discussed at our in-person meeting in June.
- Between March 1st and June, maybe we should have a sub-committee to look into the strategic framework specifically to bring up at the June 1st meeting.
- We get a lot of support from Fairtrade Canada, but not any from the others? There is no money, staff, or materials. This is not going to change.
- Support comes from the companies who use these different types of certifications. If we brought a proposal to Just-Us, Camino etc., I am sure they would commit money to the programs.
- We are contributing to these programs that is not coming from Fairtrade Canada, and this is why we feel comfortable to include these diversity of certification.
- We need to be thinking about what we are working towards, in terms of a National fair trade standard? Do
 we want four vibrant labels in this country? Something to keep in mind when approaching the subject of
 certification. France has gone about it in a certain way, presented fair trade certifications that meet
 standards.
- Could be a blend of organic and fair trade certifications.
- Consider listing the differences between certification systems
- Should pull in targets and deadlines.
- Partners in programs should be mentioned.
- EWB, Meal Exchange, Association, Fairtrade Canada
- Hear from people by March 10th in regards to Strat Framework feedback.

5 Conference Debrief

- Best conference yet, we would able to bring up and talk through things that would have not happened last year.
- Gavin shocked people, it set a tone for the conference.
- James and Andres were great.
- The sessions were thought out, months in advance and aligned with our strategic framework.
- Hotel was great, venue was good, everything went smooth.
- We still lost money on the conference, but all our board and staff costs are included.
- Maybe we should talk through conference funding strategies for students and campuses.



- Final budget came out around \$65,000, with around 225 delegates.
- Can't have a bunch of free people come, due to food costs etc.
- It would be nice to have students come and participate.
- This year we didn't do any flight sponsorship, but gave out registration codes.
- Good to communicate real registration costs for companies etc.
- Currently the registration cost is low.
- Building in signing up membership within conference registration.
- It was nice to see a growing sophistication at the conference; the conversations were not starting at the beginning again.
- People in the audience had so much information to share within the sessions.
- It would be nice to include key note speakers into meetings in Ottawa.
- Having a conference in Ottawa when we are planning to engage the government. 2019 Ottawa?
- Survey should be very concise, only 10 questions instead of 25.
- EWB conference had an app, which allowed people to give feedback following each session. The App is called Podio, integrated into SCHED. Mike has background information on this app.
- Session descriptions were not always accurate this year. Some people left the sessions because of this.
- Adding on a sub component into the EWB contract to include use of this app. Mike will look into this
 opportunity.
- Students that came with Eric, there was a component of an introductory piece missing.
- 101 and program overviews were missing.
- Need for a few 101 sessions.
- Sessions: Programs 101, stars next to knowledge levels needed for levels.
- Equifruit wants to do a proper sale workshop (Jenni Equifruit)
- Should have a call out for session idea's
- Panel discussions worked well.
- Push the speakers to being more interactive.
- Breakout sessions worked in sessions, but there was not enough time.
- Could be listed as workshops versus lectures.
- The conference schedule could be structured differently.
- Businesses were interested in a day specific to their interests.
- Should the conference by longer-shorter? 2.5 days?
- Don't want more than 3 topics per breakout
- Domestic Fair Trade needed a specific outcome
- Need to have the topics out early, which can be discussed with the Conference committee.
- Days could be themed, with the first day being educational, second day building off the first.
- It would help to at the end of the conference there is an action point for everyone to act on.
- We need to find a way to bring people together who don't agree to facilitate rational and impactful discourse. Maybe there is a speaker out there to address this issue.
- A disclaimer at the beginning of the conference to open up a meaningful and respectful conversation.
- The change labs within the EWB conference were interesting.
- Mentioning the different views within the movement and how the conference is bringing a more inclusive conversation.
- Next conference may be the time to find strong speakers, versus sourcing people who may be interested.
- We respect everyone's opinions, and maybe this is something we engrain into our vision/mission.
- Having someone to talk to if people are going through mental emotion issues.
- Facilitation of bilingualism in between the sessions.



- Boils down to how we allocated conference resources. Need to bring more money in.
- Could plant board members in sessions to be the devil's advocates.
- More participation in sessions from Board Members.
- Have board members facilitate the sessions
- Have a conference MC
- Need more French content. Eric can lead this. Need to have at least one session in French.
- Session notes can be translated.
- Registration happening earlier Tier pricing? Incentive for registration?
- Name tags double sided
- Student could do fundraising. Students are members of a larger Fair Trade Campus group, could structure funding proposals around that.
- Budget: \$13,000 in registration 32 professions, 12 students, and some professional stuff.
